



## AMERICAN KENNEL CLUB<sup>SM</sup> Application For An Indefinite Listing Privilege (ILP)

---

Thank you for your interest in the Indefinite Listing Privilege program. An ILP is not the equivalent of an AKC registration, but will enable you to compete in OBEDIENCE TRIALS, TRACKING TESTS, HERDING, LURE COURSING, AGILITY, EARTHDOG EVENTS, HUNTING TESTS and JUNIOR - SHOWMANSHIP. Dogs eligible for enrollment in the ILP program must be distinguishable as a member of a breed that has full registration status. AKC reserves the right to reject an application for cause.

**The ILP number must be written on the entry form each time the dog is entered.**

The AKC's primary function is to regulate the breeding and exhibition of registered purebred dogs. The issuance of an ILP for an unregistrable dog is strictly a discretionary accommodation. AKC would not wish to see an ILP treated as an alternate form of registration, with unregistrable dogs being bred on the basis of an ILP number. **Therefore, an ILP will be issued to an unregistrable dog of a registrable breed only if the dog in question has been spayed or neutered. Dog must be six months of age to be eligible for enrollment.**

FAILURE TO COMPLETE THE APPLICATION PROPERLY WILL RESULT IN UNNECESSARY DELAYS IN PROCESSING.

Help us process your application quickly by including ALL of the following information:

- Two recent and clear photographs (in color) of the dog in a **standing** position; one a **full front view**, and the other a side **full profile**. These photographs will become the property of The AKC and will not be returned.
- Certification that dog has been either spayed or neutered.
- A fee of \$25.00. A check or money order must accompany the application.
